Enrollment fee on or before **February 28, 2018**: \$100 for the first child and \$50 for each additional sibling.

Enrollment fee after **February 28, 2018**: \$150 for the first child and \$75 for each additional sibling.

**DISCOUNTS:**

- Payment in full: A 2% discount will be applied if tuition is paid in full by September 30, 2018.
- Kindergarten discount: Current preschool families who register their child for kindergarten will receive a 15% discount on tuition. Discount is for one year.
- Family Referral: Refer a family that registers and enrolls at SPCS for the 2018-2019 school year and receive \$500.00 off your tuition bill! (Separate rate for preschool). Discount is for one year, one per family.

**SCRIP PROGRAM:**

**TERMS OF TUITION CONTRACT**

1. Tuition may be paid in full or due each month based upon the contract plan you arrange through TADS Billing System.
2. Should any account be more than sixty (60) days in arrears, the school has the right to suspend or dismiss the student(s) from attendance at the school. In case of default of payment, the account will be referred to a collection agency. I/We agree to pay balances due, collection costs, reasonable attorney fees, and legal interest incurred. Responsible party is liable for all tuition and fees incurred for the entire calendar month the student(s) voluntarily leave(s) or is suspended or dismissed.
3. Tuition for students enrolling after the start of the school year will be pro-rated and based upon the calendar month in which the student is enrolled.
4. I/We understand that all Tuition and fees MUST be current to be eligible for re-enrollment for the next calendar school year.
5. As a condition of St. Peter Catholic School accepting the above named child(ren), I agree to follow the rules and policies established by the Principal and Pastor of St. Peter Catholic School.
6. I/We understand that participation in Catholic education at St. Peter Catholic School is a commitment of **Time and Talent** in addition to that of **Treasure**. I agree to support the school with my gifts of **Time, Talent, and Treasure** by way of volunteer assistance and participating in school fundraising activities. Parents will volunteer 20 hours for their preschooler and 30 hours for their K-8 student during the school year (per family).
7. I/We understand and will uphold the mission of St. Peter Catholic School and will promote the environment of Christian respect and love.
8. **I/We understand that participation in the SCRIP program is mandatory for grades K-8. A \$150 minimum earnings is required and must be paid prior to the 2018-2019 school year. Payment is due by August 15, 2018.** Earnings accrued above \$150 in your SCRIP account is applied to your tuition for the next school year. Eighth grade students, with no returning siblings to St. Peter Catholic School, will have the balance (after the first \$150 is transferred) of their SCRIP account applied to their tuition in April of their graduating year. Families not returning to St. Peter Catholic School the following school year will forfeit their SCRIP rewards.
9. Continued enrollment will be based on a semester by semester review. The previous semester's tuition must be paid in order to continue in the next semester and successive school year.
10. I/We hereby acknowledge that as the parent or legal guardian of the child(ren) being registered, I am responsible to keep all information authorizations pertaining to the child(ren) correct and current at all times.
11. I/We understand that my child(ren) may not be registered until all forms are completed, submitted, and approved.
12. I/We understand that initial enrollment is contingent upon successful completion of this Tuition Contract and applicable fees.
13. **I/We understand that the Registration Fee is NON-REFUNDABLE.**
14. I/We understand there will be a \$500 withdrawal fee assessed for any withdrawal prior to the last day of the 2018-2019 academic year. Refunds of any remaining tuition may take up to 90 days.

*I/We agree to abide by with the terms and conditions stated in this Tuition Contract. I/We have had the Tuition Contract explained and been provided the opportunity for questions. I/We understand this is a legal, binding, and enforceable contract.*

*I/We agree the tuition amount is accurate and will pay this amount. I/We am aware that additional discounts may be applied at a later date due to financial aid. Further, I/We agree to pay the tuition amount faithfully, and I understand that the presence of my child(ren) at St. Peter Catholic School is dependent upon the adherence to this Tuition Contract.*
