K-8 DISCOUNTS:

- Payment in full: A 2% discount will be applied if tuition is paid in full.
- Kindergarten discount: Current preschool families who register their child for kindergarten will receive a 15% discount on tuition. Discount is for one year.
- Family Referral: Refer a family that registers and enrolls at SPCS for the 2021-2022 school year and receive \$500.00 off your tuition bill! (Separate rate for preschool). Discount is for one year, one per family.

SCRIP PROGRAM:

It is mandatory for all K-8 families to participate in the SCRIP program. Please refer to the Terms of Tuition Contract for more information. **All families will be charged a \$150.00 scrip fee in their tuition agreement.**

PRESCHOOL DISCOUNTS:

- Payment in full: A 2% discount will be applied if tuition is paid.
- Sibling Discount: Siblings (the lesser tuition) receive a 10% discount.
- Family Referral: Refer a family that registers and enrolls at SPCS for the 2021-2022 school year and receive \$250.00 off your tuition bill! Discount is for one year, one per family.

TERMS OF TUITION CONTRACT

1. Tuition may be paid in full or due each month based upon the contract plan you arrange through TADS Billing System.
2. Should any account be more than sixty (60) days in arrears, the school has the right to suspend or dismiss the student(s) from attendance at the school. In case of default of payment, the account will be referred to a collection agency. I/We agree to pay balances due, collection costs, reasonable attorney fees, and legal interest incurred. Responsible party is liable for all tuition and fees incurred for the entire calendar month the student(s) voluntarily leave(s) or is suspended or dismissed.
3. Tuition for students enrolling after the start of the school year will be pro-rated and based upon the calendar month in which the student is enrolled.
4. I/We understand that all Tuition and fees MUST be current to be eligible for re-enrollment for the next calendar school year.
5. As a condition of St. Peter Catholic School accepting the above named child(ren), I agree to follow the rules and policies established by the Principal and Pastor of St. Peter Catholic School.
6. I/We understand that participation in Catholic education at St. Peter Catholic School is a commitment of **Time and Talent** in addition to that of **Treasure**. I agree to support the school with my gifts of **Time, Talent, and Treasure** by way of volunteer assistance and participating in school fundraising activities. Parents will volunteer 20 hours for their pre-schooler and 30 hours for their K-8 student during the school year (per family).
7. I/We understand and will uphold the mission of St. Peter Catholic School and will promote the environment of Christian respect and love.
8. **I/We understand that participation in the SCRIP program is mandatory for grades K-8.** All families will be charged a \$150 Scrip fee in their tuition agreement. Earnings accrued in your SCRIP account are applied to your tuition for the next school year. Eighth grade students, with no returning siblings to St. Peter Catholic School, will have the balance of their SCRIP account applied to their tuition in April of their graduating year. Families not returning to St. Peter Catholic School the following school year will forfeit their SCRIP rewards.
9. Continued enrollment will be based on a semester by semester review. The previous semester's tuition must be paid in order to continue in the next semester and successive school year.
10. I/We hereby acknowledge that as the parent or legal guardian of the child(ren) being registered, I am responsible to keep all information authorizations pertaining to the child(ren) correct and current at all times.
11. I/We understand that my child(ren) may not be registered until all forms are completed, submitted, and approved.
12. I/We understand that initial enrollment is contingent upon successful completion of this Tuition Contract and applicable fees.
13. **I/We understand that the Registration Fee is NON-REFUNDABLE.**
14. I/We understand there will be a \$500 withdrawal fee assessed for any withdrawal prior to the last day of the 2021-2022 academic year. Refunds of any remaining tuition may take up to 90 days.

I/We agree to abide by with the terms and conditions stated in this Tuition Contract. I/We have had the Tuition Contract explained and been provided the opportunity for questions. I/We understand this is a legal, binding, and enforceable contract.

I/We agree the tuition amount is accurate and will pay this amount. I/We am aware that additional discounts may be applied at a later date due to financial aid. Further, I/We agree to pay the tuition amount faithfully, and I understand that the presence of my child (ren) at St. Peter Catholic School is dependent upon the adherence to this Tuition Contract.
